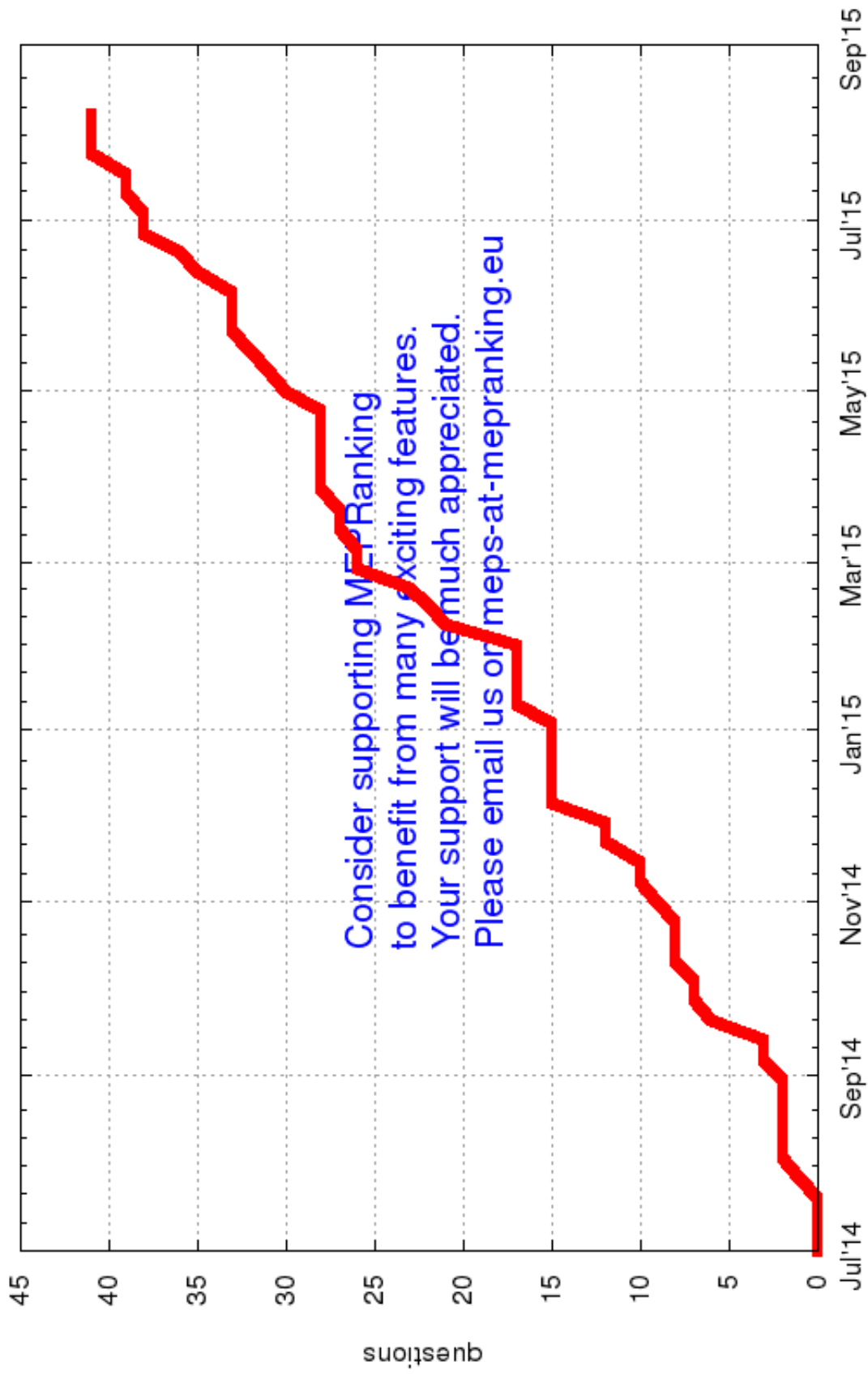

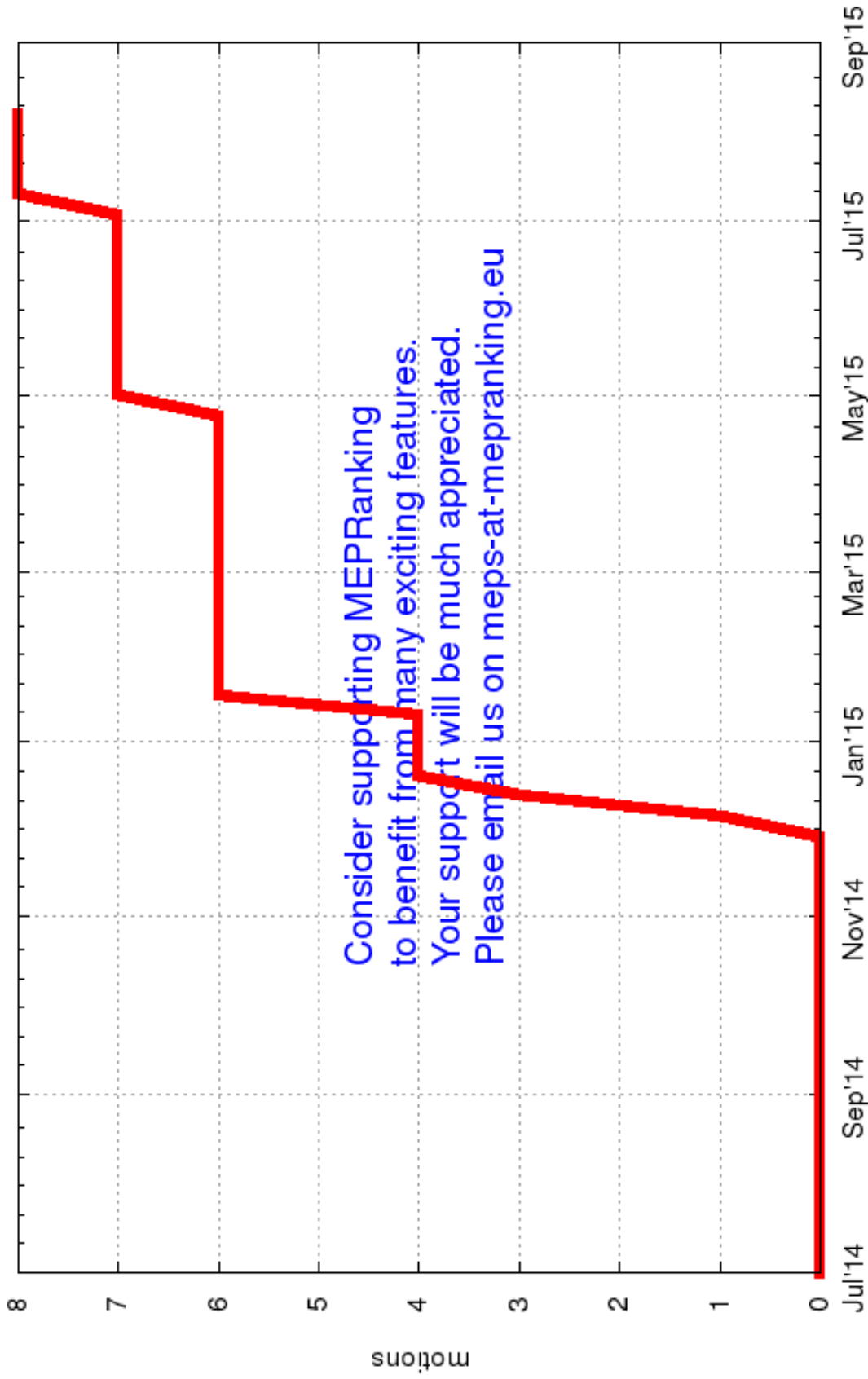

## QUESTIONS of Antonio TAJANI in the EP (8th term)



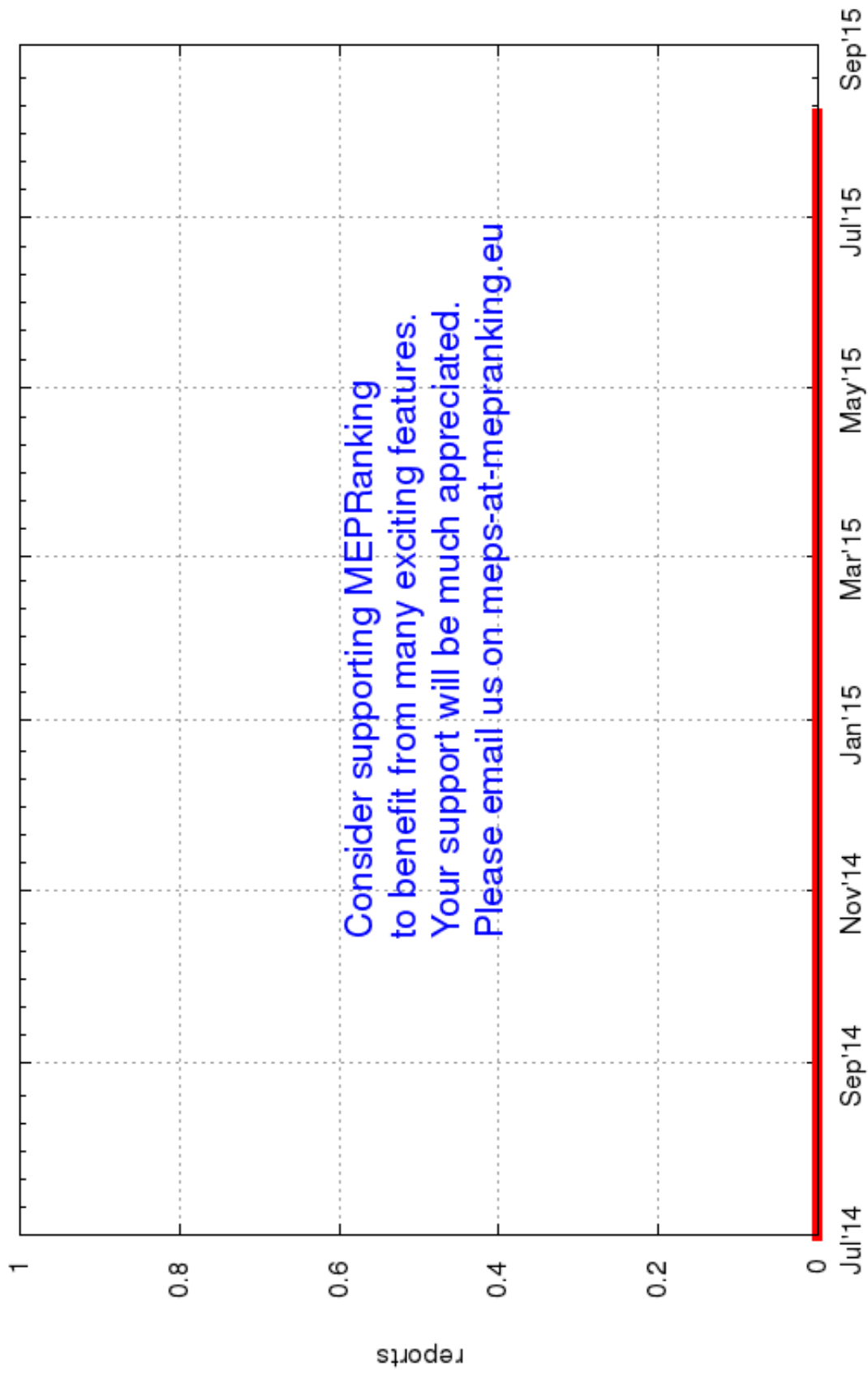


### MOTIONS of Antonio TAJANI in the EP (8th term)



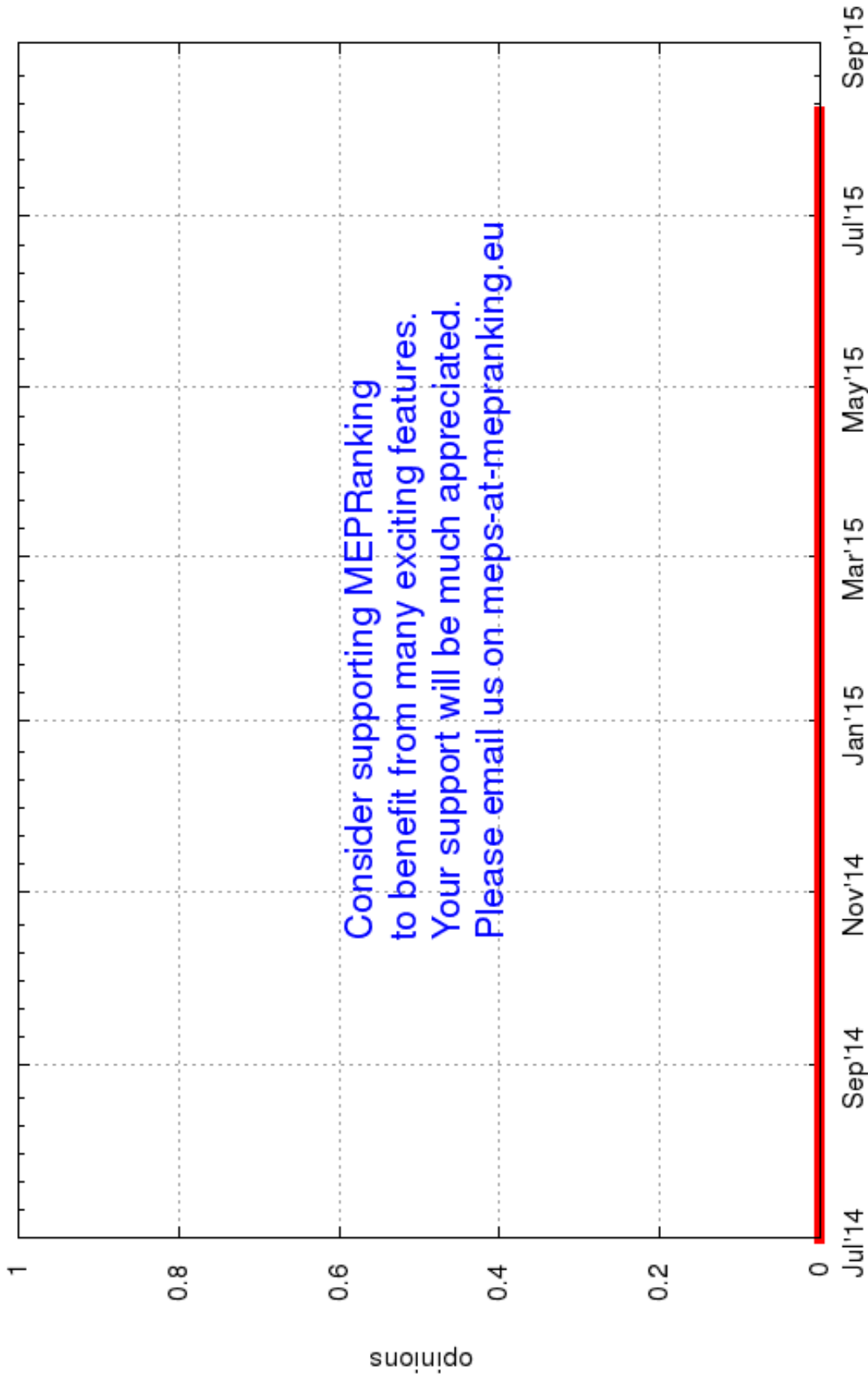

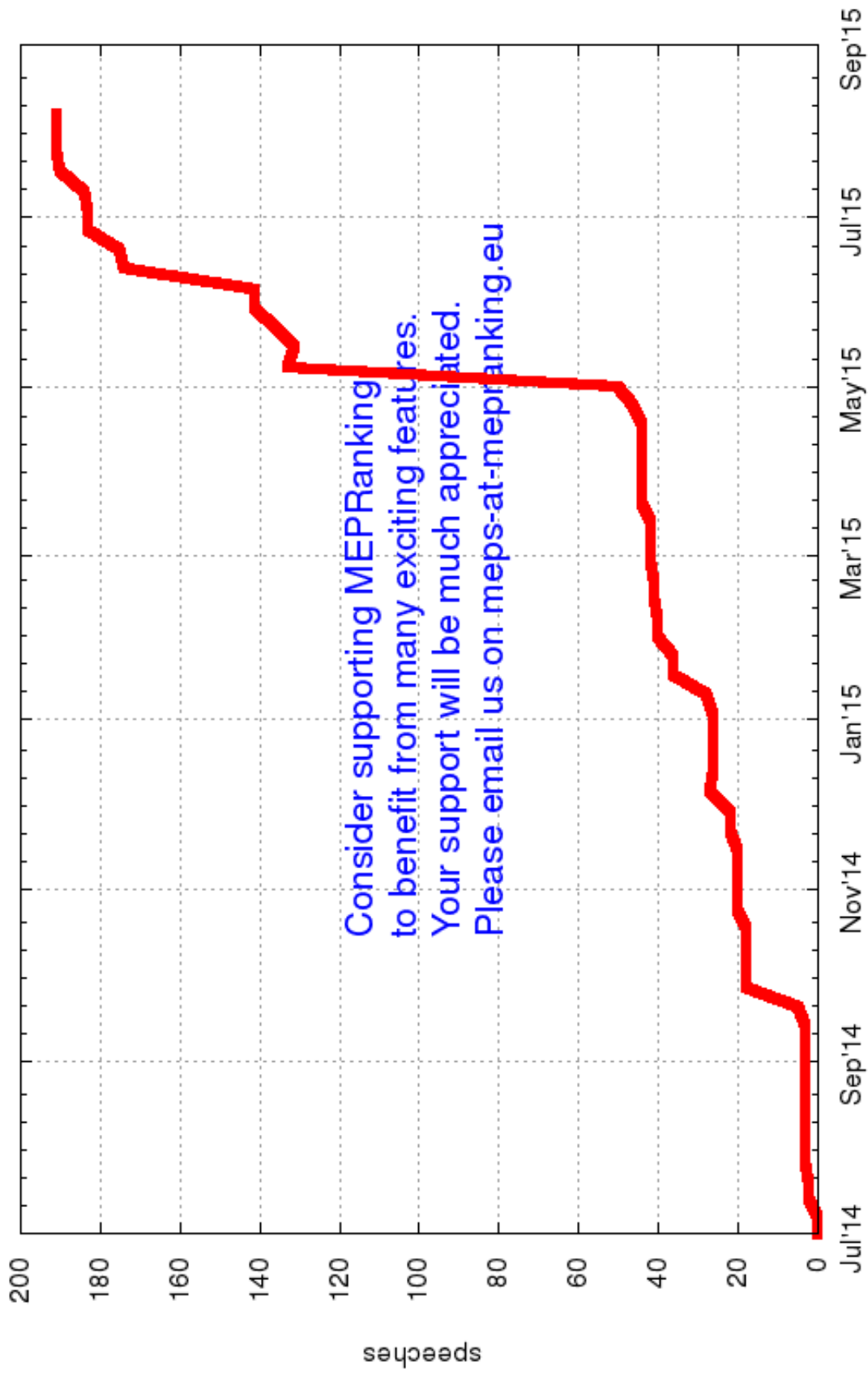

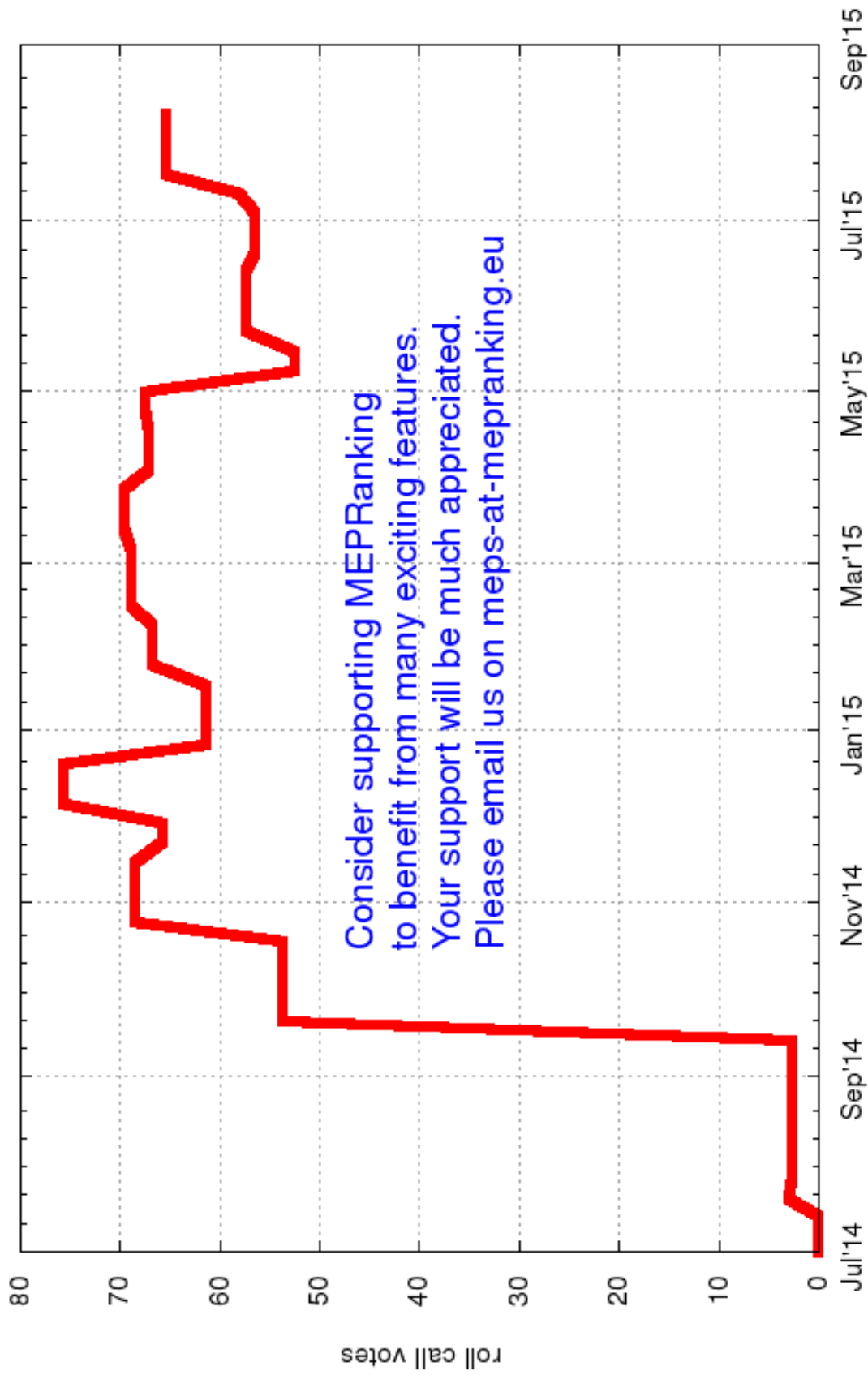
