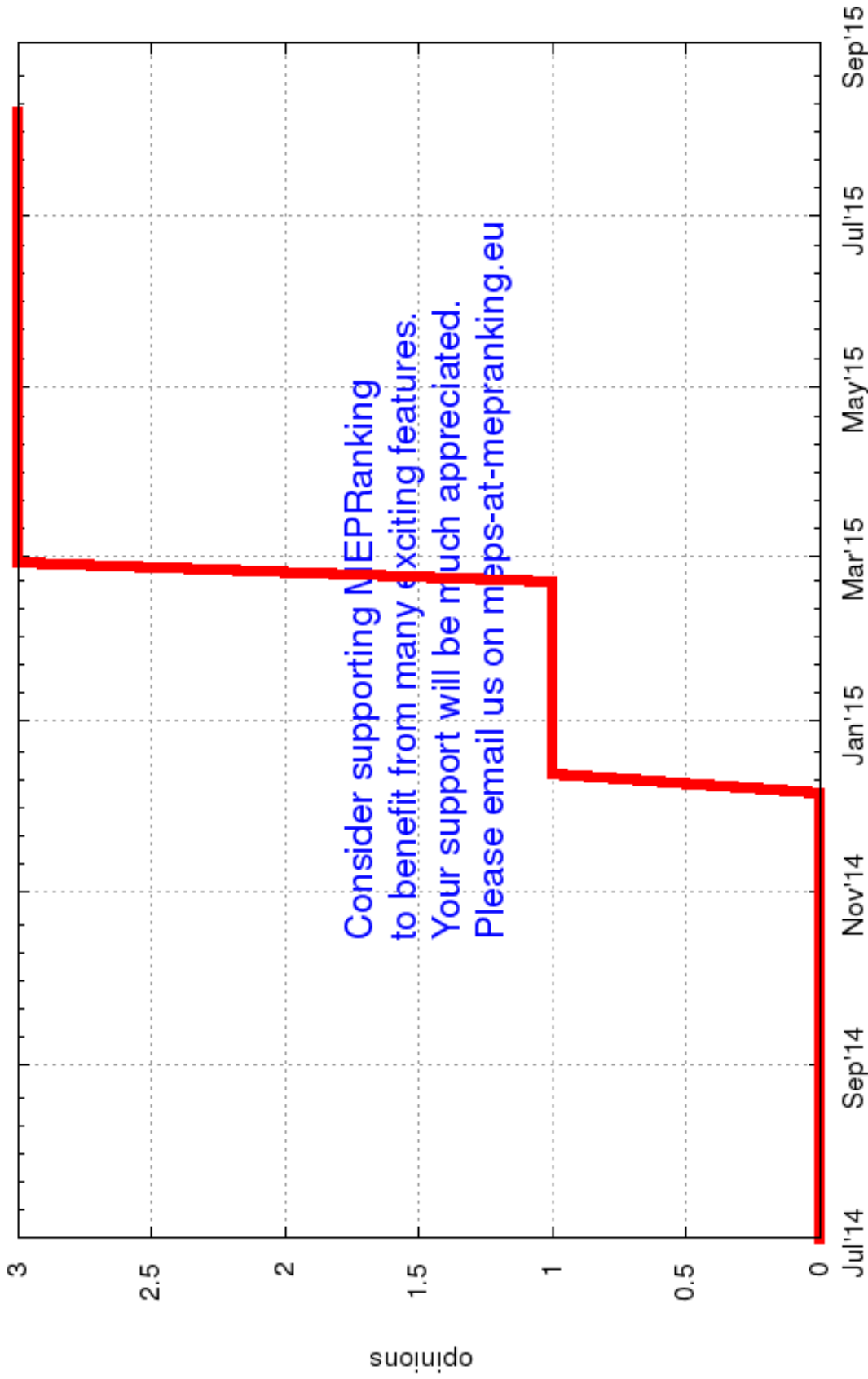

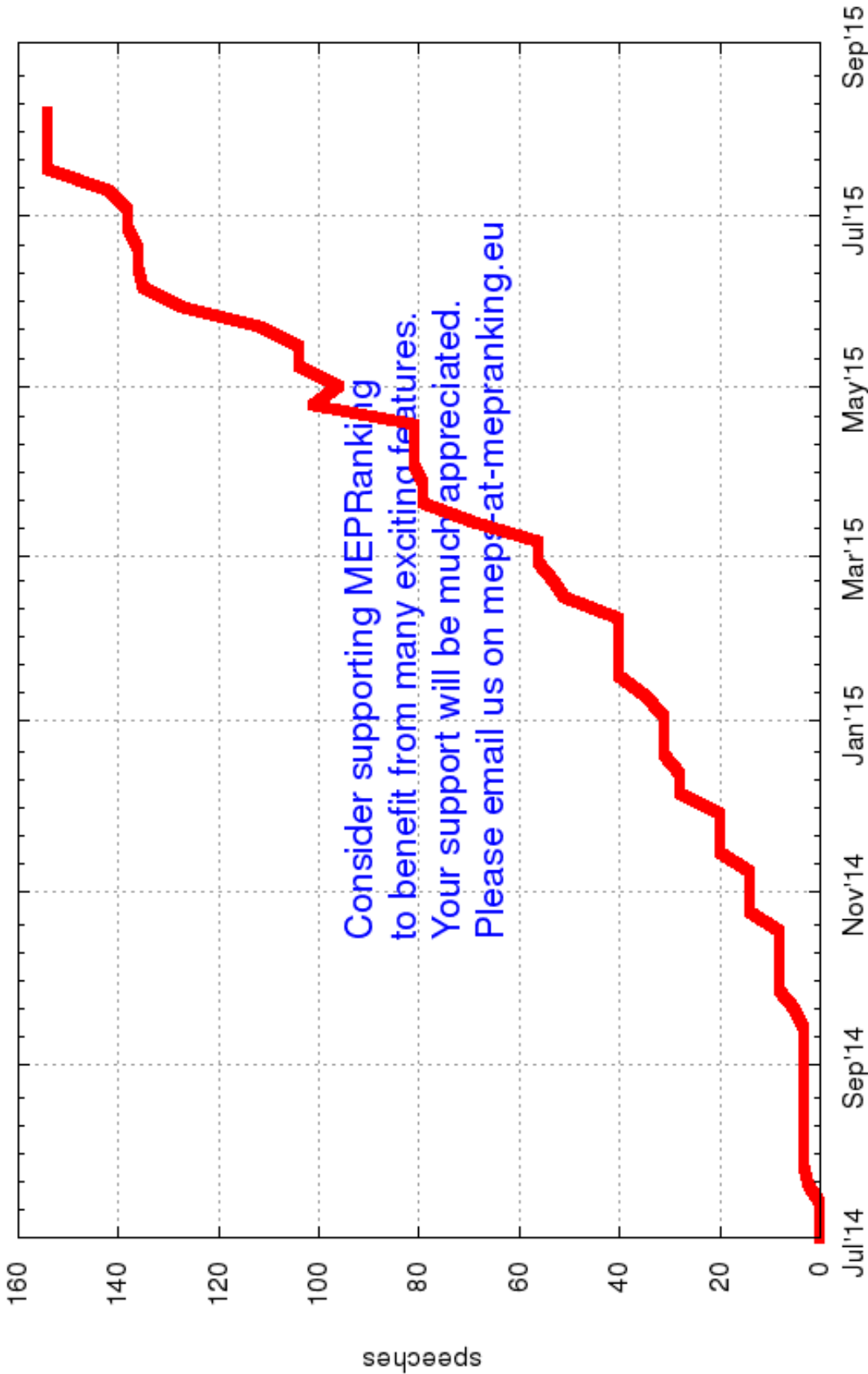

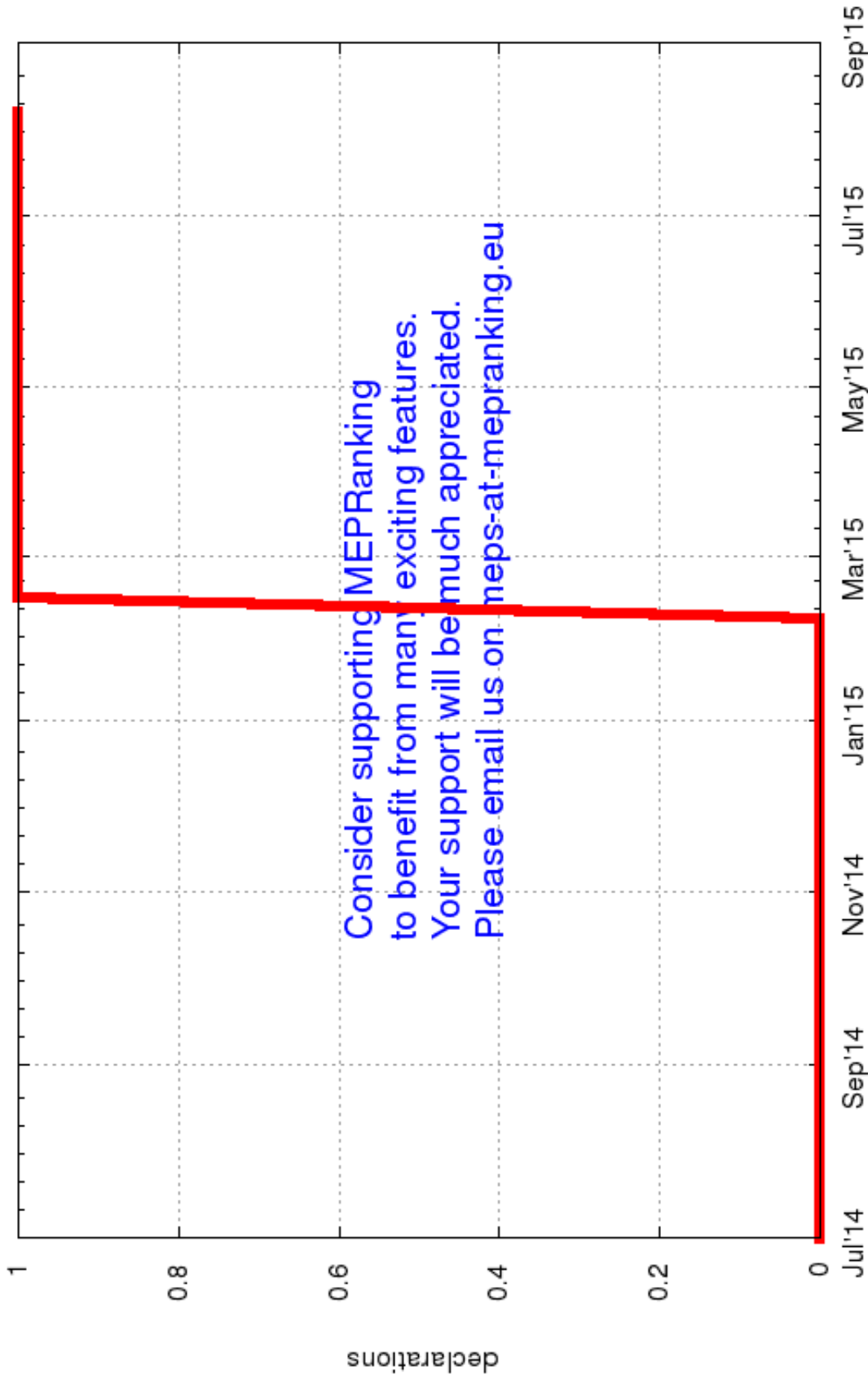

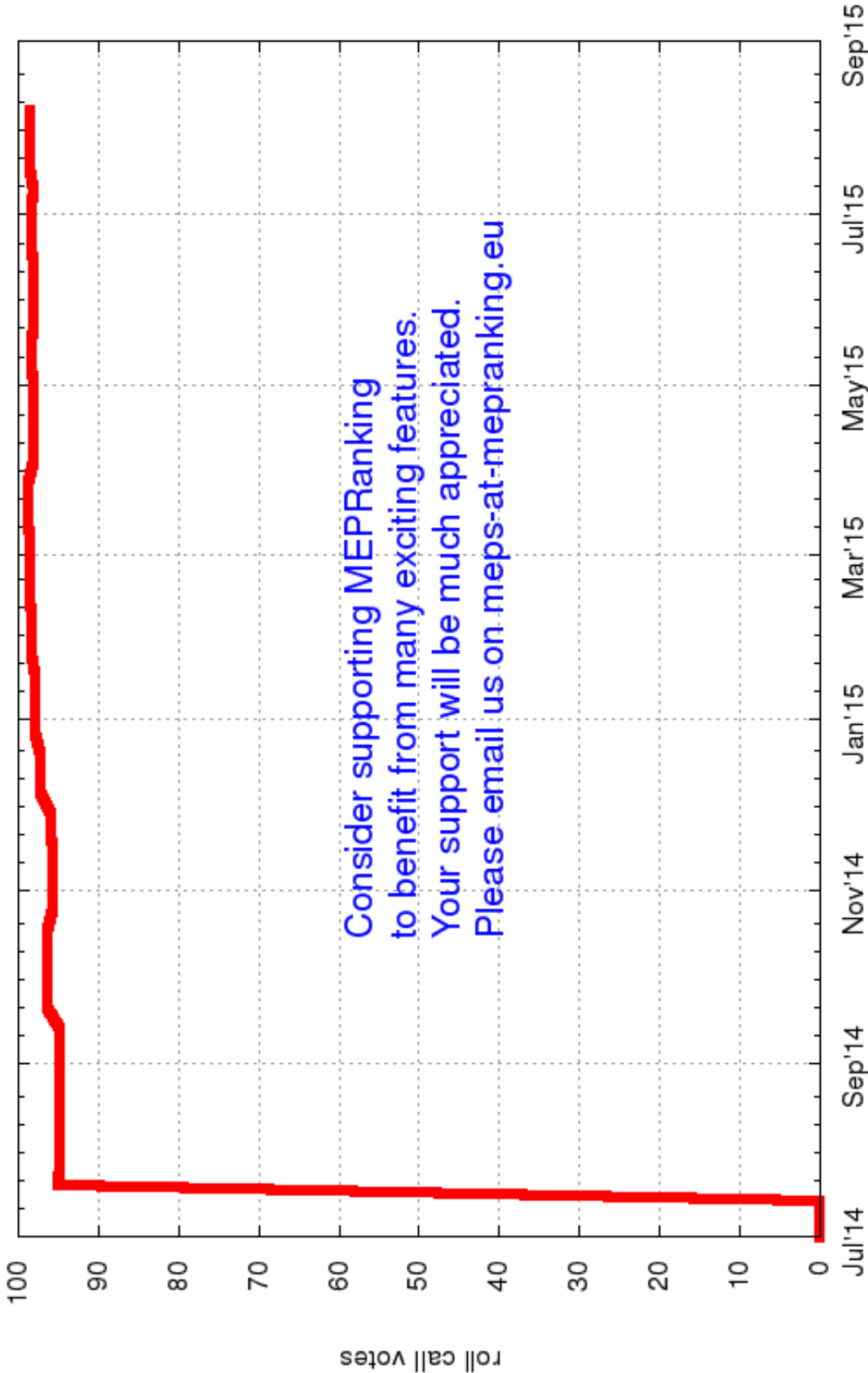


DECLARATIONS of Ryszard CZARNECKI in the EP (8th term)
