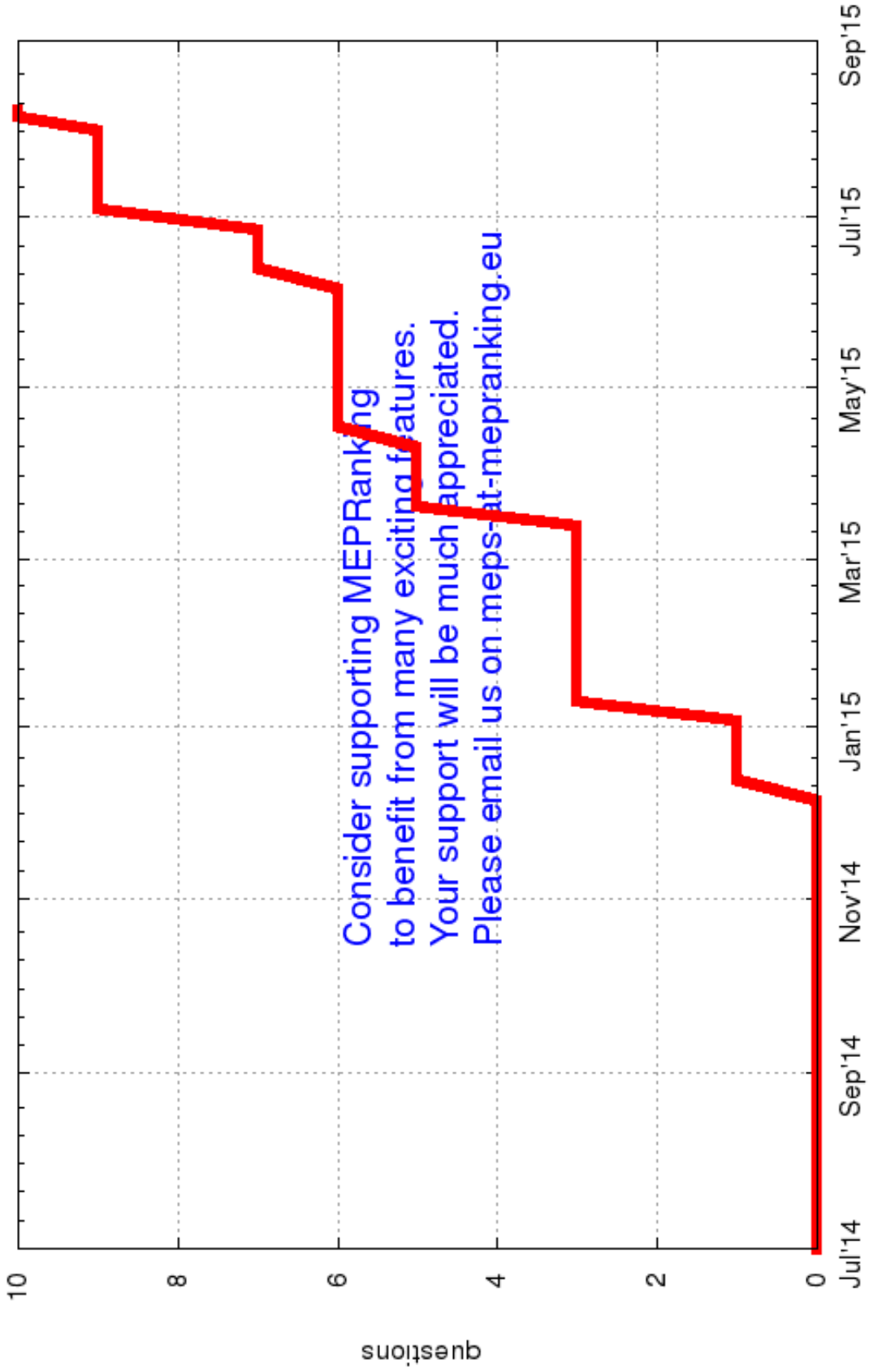

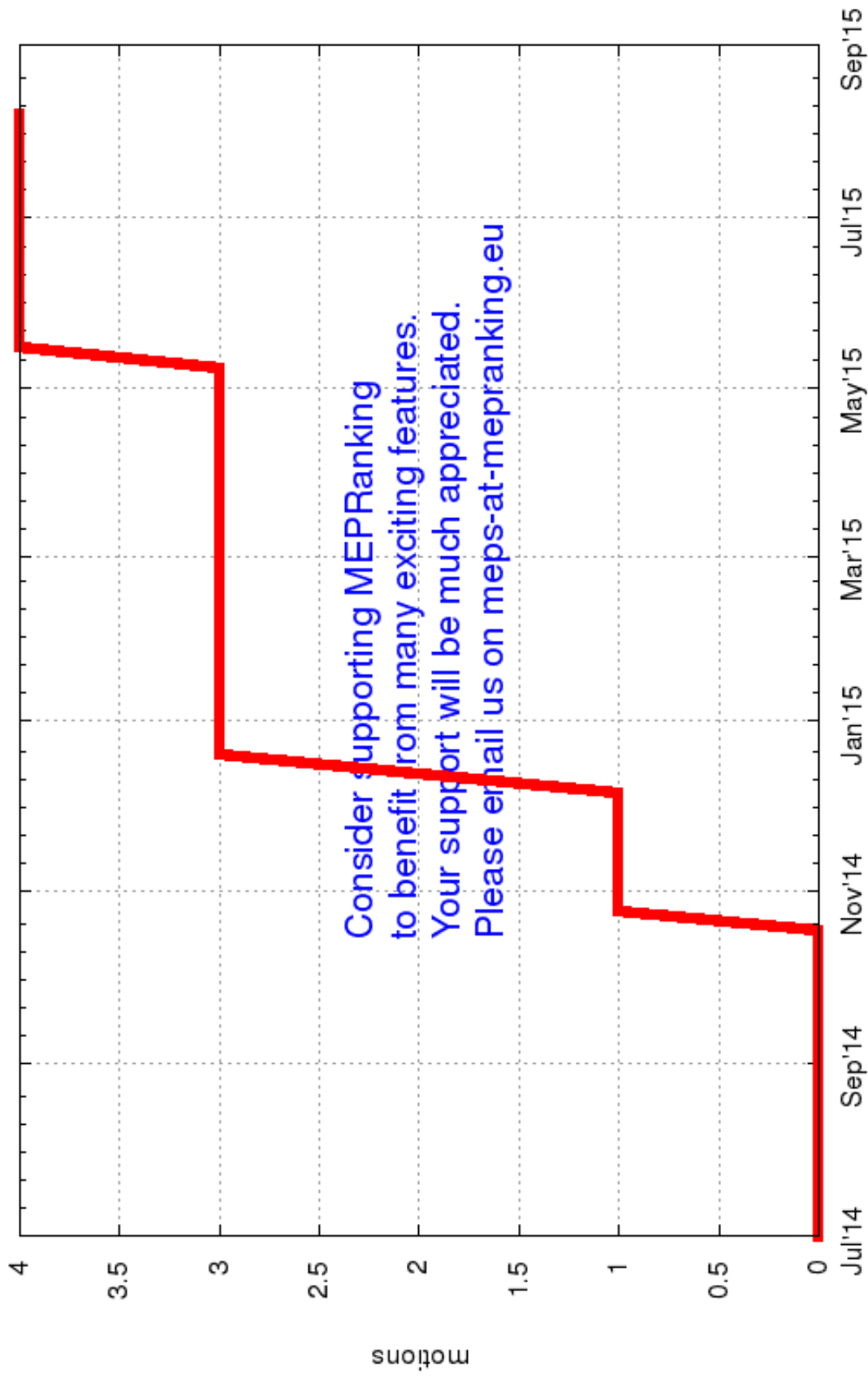

### QUESTIONS of Philippe LAMBERTS in the EP (8th term)



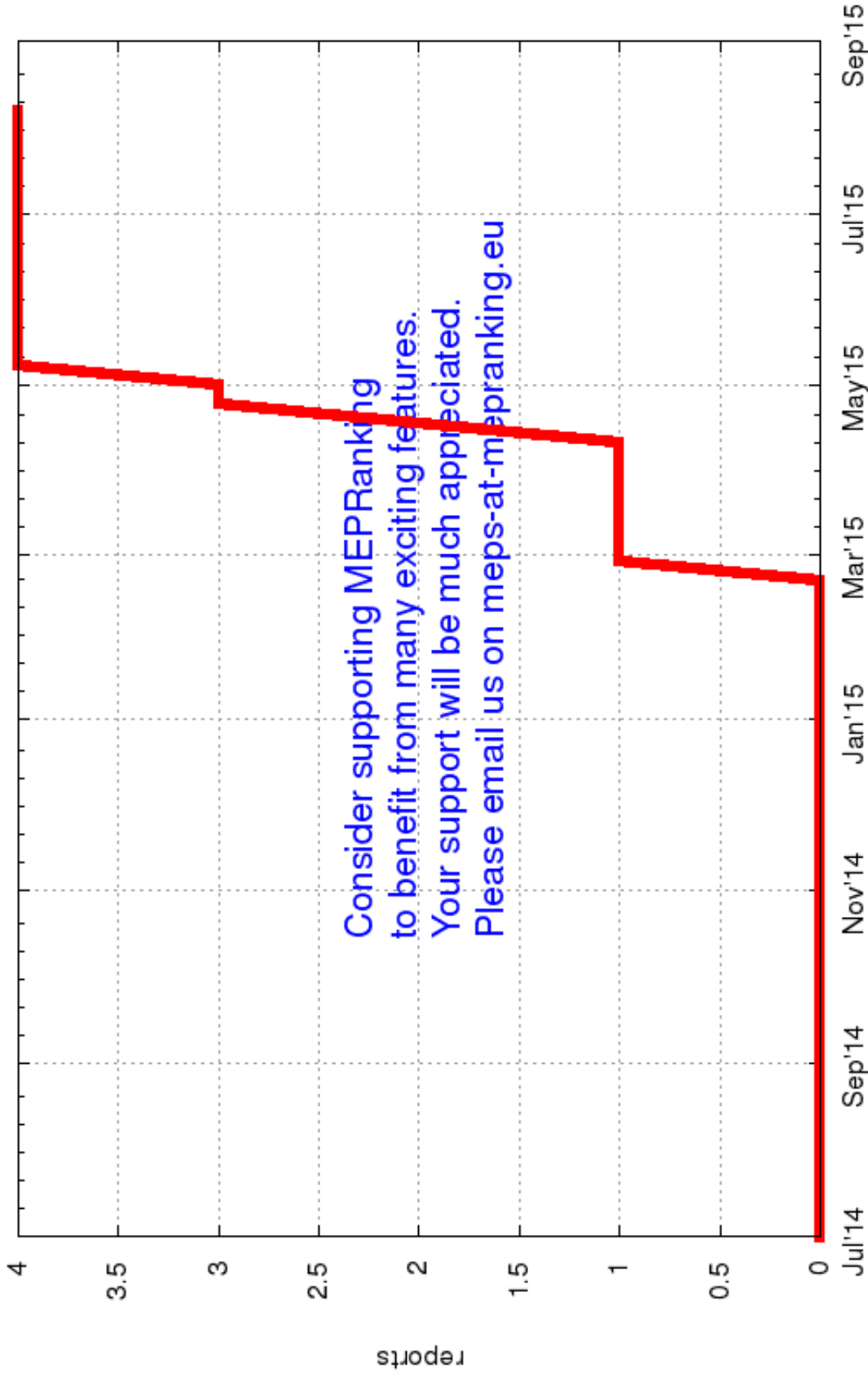

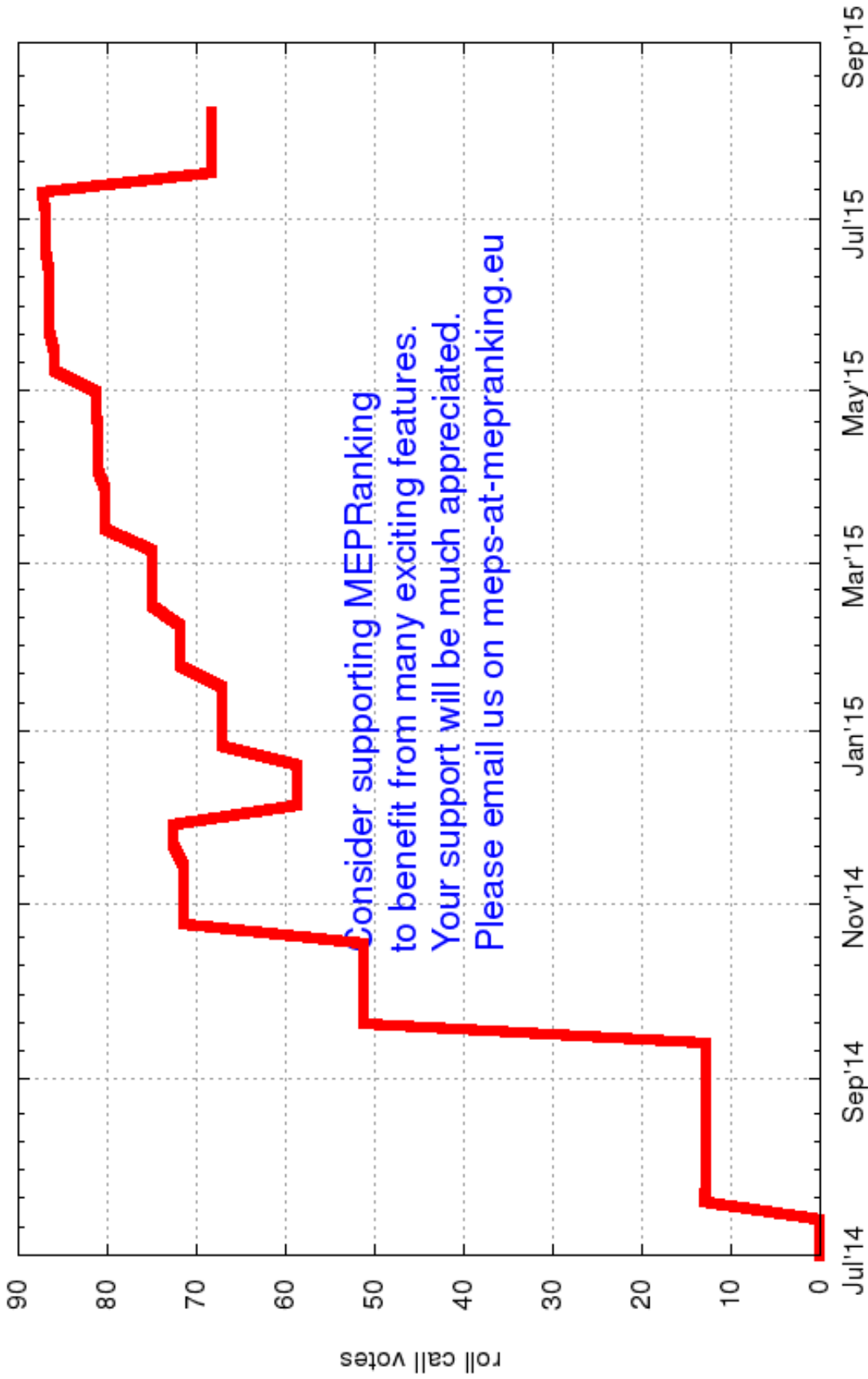
